



## 2010 Boiler Seminars and Exams Registration

This seminar covers material for the Special and Second Class Engineer License exams for the State of Minnesota. At class you will receive a handout that covers all material for the exam. **Class begins at 8:30 a.m. at MHA** and the test is at 2:30 p.m. (a representative from the Department of Labor and Industry will administer the exam.)

No experience is necessary for the Special Class License. Those wishing to upgrade to the Second Class License must have had their Special Class License for at least one year and it must be active. **All registrants must complete and mail in to MHA an original Boiler Boat Masters License Application and those applying for the Second Class License must also complete and mail in an original affidavit** (These documents are on our website: [www.mmha.com](http://www.mmha.com) under Boiler Seminar & Exam). **COPIES AND/OR FAXES WILL NOT BE ACCEPTED.** Once MHA registers you and applies to the state, you will receive a confirmation both from MHA and the MN Department of Labor and Industry. Please note that the state confirmation will list the 2:30 pm exam time only.
